

THE 2021 UNFI SING IT WITH OREO SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE OR TEXT MESSAGE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR TEXT MESSAGE WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The 2021 UNFI Sing It With Oreo Sweepstakes ("Sweepstakes") is sponsored by Mondelēz Global, LLC ("Sponsor"), 100 Deforest Avenue, East Hanover, NJ 07936 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on February 1, 2021 at 12:00 PM Eastern Time ("ET") and ends on March 6, 2021 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees, officers and directors of Sponsor, Administrator, Phoenix Creative, Co., HMT Associates, Inc., United Natural Foods, Inc., SUPERVALU, Inc., and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their respective immediate family members (e.g., spouse, biological or adoptive parents, child, sibling, grandparents, in-laws, grandchildren, each their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited by law.

Participation constitutes entrant's (or his/her parent's or legal guardian's, if entrant is deemed a minor in the jurisdiction in which s/he resides ("Minor") full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address after entering.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, there are two (2) ways to enter:
 - A. **Purchase and Text Message Entry:** An entrant may, during the Sweepstakes Period, purchase two (2) or more packages of OREO Cookies (6 oz. or larger) (see Appendix for participating products) in one (1) transaction from any participating SuperValu store ("Qualifying Purchase"), while supplies last. Then, using an SMS-enabled mobile device, an entrant must send a text message to the short code "87654" ("Short Code") stating the keyword "OREO" ("Keyword"). Once the text message is received, the entrant will be sent one (1) reply text message from an automated system asking the entrant (or his/her parent or legal guardian if entrant is a Minor) to take a picture of the original Qualifying Purchase receipt and submit it by return text and agree to these Official Rules. The receipt must clearly show the date of purchase and items comprising the Qualifying Purchase in order to be deemed valid. Upon receipt of a valid Qualifying Purchase receipt, Keyword, and agreement to these Official Rules, an entrant will receive another automated text message confirming his/her entry and will automatically receive one (1) entry into the Sweepstakes ("Text Message Entry"). Only Text Message Entries to the Short Code with a valid Qualifying Purchase receipt, the valid Keyword, and agreement to these Official Rules will be accepted as a valid Text Message Entry. If chosen as a winner, entrant will receive another automated text message from the Sponsor. See Section 6 ("How to Claim a Prize") for details

regarding how potential winners who entered using this entry method will be notified. All Text Message Entries must be received by Sponsor or its authorized designee by 11:59:59 PM ET on March 6, 2021. NOTE: Proof of text message submission does not constitute proof of delivery or receipt of the text message.

IMPORTANT: Standard message and data rates may apply for each text message sent or received in accordance with the terms of your service agreement. Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes. Entrants should consult their wireless provider's pricing plans prior to entering via text message. By texting the Keyword to the Short Code, you (or your parent or legal guardian if you are a Minor) provide to the Sponsor and Administrator your (or your parent's or legal guardian's if you are a Minor) express written consent for you to receive up to eight (8) text messages per entry using automated technology in connection with your participation in the Sweepstakes. Consent to receive text messages is not required or a condition of any purchase of goods or services An entrant may, at any time, choose to stop participating in this Sweepstakes by sending an opt-out text message stating "STOP OREO" to the Short Code. If an entrant sends an opt-out text message, he/she will be sent one (1) reply text message, which will confirm that he/she has been unsubscribed and will receive no further text messages. For help, text the word "HELP OREO" to the Short Code. Each Text Message Entry must be manually key-stroked/entered by the entrant.

- B. Mail-In Entry:** To enter without making a purchase, an eligible entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY) on an approximately 3½"x5" card or piece of paper ("Mail-In Entry") and mail it in an envelope with sufficient postage to: The 2021 UNFI Sing It With Oreo Sweepstakes, P.O. Box 251328, West Bloomfield, MI 48325. All Mail-In Entries must be postmarked no later than March 6, 2021, and received on or before March 16, 2021, in order to be eligible.

Mail-In Entries must be legibly hand-written and contain all required information. Mechanically reproduced or postage-due Mail-In Entries, or Mail-In Entries sent in excess of the entry limits set forth below or received without a verifiable and legible return address will not qualify for inclusion in the prize drawing described in Section 4, below.

Entry Limit: Regardless of the method of entry, there is a limit of one (1) entry per person per day during the entire Sweepstakes Period. If more than one (1) entry is received from the same person, telephone number, postal address and/or e-mail address in a single day, entrant may be disqualified. A "day" is defined as starting at 12:00 AM (midnight) ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period, except on February 1, 2021 when a day is defined as starting at 12:00 PM ET and ending at 11:59:59 PM ET.

- 4. RANDOM DRAWING:** On or about March 17, 2021, the Administrator will randomly select three (3) potential grand prize winners and one hundred (100) potential first prize winners from all eligible entries received through both entry methods combined. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

- A. Grand Prizes (3):** The grand prize is a trip for two (2) to Chicago, Illinois to see Lady Gaga in concert ("Grand Prize"). Trip includes round-trip coach class air transportation from a major commercial airport near winner's residence (determined by Sponsor in its sole discretion) to Chicago, Illinois for winner and one (1) guest, two (2) nights hotel standard accommodations

(one room/double occupancy), roundtrip ground transportation between airport and hotel, two (2) tickets to the Lady Gaga concert on August 27, 2021, \$1,300 spending money (for winner only), and an OREO prize package that includes an OREO music box, a pair of OREO branded Bluetooth headphones, a ceramic mug set, and a microphone (for winner only). If winner is a Minor, his/her guest must be winner's parent/legal guardian. If the winner elects to travel or partake in the Grand Prize without a guest, no additional compensation will be awarded to the winner in lieu of guest. Winner and guest must travel on August 26, 2021 and return on August 28, 2021 or the Grand Prize will be forfeited. Winner and guest must travel together on the same itinerary. The actual value of the trip may vary depending on point of departure and fluctuations in the cost of air transportation. Any difference between the ARV and the actual value of the prize will not be awarded. If winner resides within a 100-mile radius of Chicago, IL, ground transportation may be provided in lieu of air transportation, and no compensation will be provided for any difference in value. Travel dates are subject to availability; blackout dates and other restrictions may apply. Winner and guest are responsible for having valid travel documents including government identification and/or passports. Winner will be required to provide a major credit card upon hotel check-in, and all in-room charges will be charged to the credit card. Any damage to the room will be the responsibility of the winner. **Sponsor bears no responsibility if any event, element or detail of the prize is canceled, postponed or becomes unavailable for any reason.** Should any event, element or detail of the prize become unavailable, the Sponsor shall have no obligation to the winner aside from providing the remaining portion of the prize, minus any unavailable event, element or detail. Sponsor is not responsible if the event is delayed, postponed, or canceled for any reason. Winner will not receive compensation from Sponsor for tickets that the winner is unable to use due to cancellation of the event, but tickets may be subject to standard rain-check policies and procedures set by the issuer. Winner (or his/her parent/legal guardian if winner is a Minor) agrees that event admission is awarded pursuant to a revocable, nontransferable license that is personal to that winner, and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated or otherwise conveyed. Sponsor reserves the right to remove or to deny entry to winner and/or his/her guest if either winner or his/her guest violates the previous restrictions or engages in a disruptive manner, or with intent to abuse, threaten or harass any other person at the event. No more than three (3) Grand Prizes will be available in the Sweepstakes. The ARV of each Grand Prize is \$5,623.

- B. First Prizes (100):** Each first prize is an OREO prize package that includes an OREO music box, a pair of OREO branded Bluetooth headphones, a ceramic mug set, and a microphone (each a "First Prize"). No more than one hundred (100) First Prizes will be available in the Sweepstakes. The ARV of each First Prize is \$200.
- C. Total ARV:** The total ARV of all prizes is \$36,869.
- D. Odds of Winning:** The odds of winning a prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period through both entry methods combined.
- E. General Conditions:** There is a limit of one (1) prize per household. In no event will more three

(3) Grand Prizes and one hundred (100) First Prizes, be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible notifications/prize claims received.

6. HOW TO CLAIM A PRIZE: The potential winners are subject to verification of eligibility and compliance with these Official Rules. After the random drawing, Administrator will notify each potential winner via telephone or e-mail at the telephone number or e-mail address provided at the time of entry. Each potential Grand Prize winner (or his/her parent/legal guardian if winner is a Minor) will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of first attempted notification or the Grand Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Upon verification of eligibility, each Grand Prize winner will be contacted to make arrangements for the Grand Prize and each First Prize will be mailed to the winners at the physical addresses (P.O. Boxes are not permitted) provided at the time of entry 6 to 8 weeks after winner verification. Any portion of a prize not accepted by winner will be forfeited. **Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for his/her prize won.** Sponsor will issue an IRS Form 1099-MISC for each Grand Prize winner. All other costs and expenses not expressly set forth herein shall be solely each winner's responsibility. The prizes will only be awarded to verified winners.

Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, illegible, deleted, damaged, garbled or otherwise not in compliance with the Official Rules.
